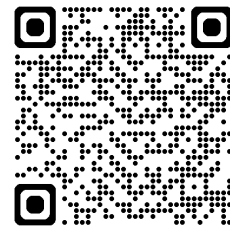

Needed: a change of direction, not just an improvement in messaging

Within a week of the local elections, there were around 100 Labour MPs calling for a leadership election, according to LabourList. It seems inevitable that Starmer will be challenged sooner or later - inevitable, and necessary. But any leadership election - whenever it comes, must be an opportunity for a thoroughgoing debate on the direction of the government and party, not just presentation.

It is to be hoped that the Socialist Campaign Group MPs put up a candidate and campaign for sufficient nominations. We urge union and party branches to discuss and support that candidacy once known, and to call on their MPs to nominate.

NEC - stick to the rules this time

Party rules allow CLPs and affiliates to nominate any PLP member of their choice. But for last year's Deputy Leader contest, the NEC invented a new rule; copying the process in the Conservative Party, they declared that the PLP nominations would come first, and that the outcome of this invented 'first stage' would limit the rights of CLPs and affiliates.

We urge CLPs and affiliates to pass motions to be sent to the NEC, calling for no undermining of the rules whenever the leadership election comes.

We must win in Makerfield

LLI supporters have been joining the hundreds from around the country who have been campaigning to elect Andy Burnham in Makerfield. A Labour victory in Makerfield would push back the Reform at their height, and potentially turn the tide. A Labour loss would do the reverse. Polls show a widening gap to our advantage, but still within the margin of error, and worse if the Restore vote collapses into Reform. Every effort is still needed.

A Labour victory would also accelerate the necessary job of removing Starmer. Andy Burnham was clear at his campaign's launch that his campaign was about changing Labour: "My own party needs to change - a vote for me in this by-election is a vote to change Labour - to be a party that is solidly on the side of working class people and working class communities".

There is no doubt that Burnham is widely seen - within the public as well as the party - as representing something different to Starmer. He talks about government having been on the wrong course for four decades (implicitly disavowing

the Blair government and his own part in it) and the damage done by successive privatisations.

He calls for "the biggest council housing building programme since the Second World War", for "care on NHS terms", and more improved public transport - with the GM Bee Network presented as showing what can be done.

Burnham has been accused of backsliding on things like public ownership, (as he has on some other things) but actually when he refers carefully to 'public control', rather than 'public ownership' this is accurate for Manchester's buses and trams, that are privately owned (and profited from) but publicly commissioned. Mayoral commissioning has enabled some improvements to be made for passengers and clean air, but is very limited in what can be achieved next. It is no answer to Thatcher's privatisations, to the need to control banking, or the challenges of climate change. Campaign Group MP Clive Lewis was absolutely right at the recent Mainstream members' meeting - whilst urging the biggest possible effort for Labour in Makerfield - to point out that 'public control' is what we have with water; what we need is public ownership.

We must win in Makerfield, push back Reform, and hold a proper debate across the whole movement on the way forward.

"The question for us in the Socialist Health Association is not whether Starmer goes, but who comes next. Wes Streeting's resignation letter opened, "The results are in and I am pleased to report that I have delivered against the ambitious targets you set for me when I became your Secretary of State for Health and Social Care." We ask whether his tenure actually fixed anything, or whether his excitable rhetoric obscures a record that, on close examination, has brought the NHS closer to its ultimate demise."

Movement on EU?

Over the last five months more and more positive noises about the relationship with the EU have been emanating from the Labour Government, the PLP and some Labour Mayors. These include Starmer's unfortunately dated 1st April speech and Reeves' Mais Lecture speech.

Earlier this month even the Labour Movement for Europe has moved from its "anything but the single market" line, to a call to "Rip up the Redlines", and for the European Movement, an organisation of 250,000 members, to call for the UK to rejoin the single market. It's unfortunate that the Government just can't seem to meet the goals that its rhetoric sets, as seen by this report, in the Guardian where the Government's big idea for rescuing the Reset is a "single market for goods". It confirms what the House of Commons select committee said in a devastating and frank report, published on a web page entitled, "UK-EU reset lacks "direction, definition and drive"". Its chairperson, Emily Thornberry, is quoted as saying "Sadly, we found that despite progress in some areas, the Government's reset is languishing, suffering from a lack of direction, definition and drive. It feels as though we are on a journey with no clear destination. In many areas, the Government has failed to provide timelines, milestones, or priorities and it

does not appear to have an ambitious, strategic vision for the UK's new relationship with the EU."

Some contributions to the debate, seem to be an attempt to place a firewall between the views of Labour's members and the majority of people in the country and the political direction of the government. It might be pleasing to see Wes Streeting's comments in the light of this movement within the Party and its supporters. He described it as a catastrophic mistake, but we need to recognise that this could be designed as a trap for Andy Burnham who has to win a by-election in an area that 10 years ago voted strongly to leave the EU. Certainly, Burnham's response has not been particularly sure-footed.

Rejoining the EU needs a mandate, but rejoining the customs union and single market would be simple steps that do not and the coming European Partnership Bill may be a suitable vehicle to make these changes. Certainly the current Labour leadership lacks the ambition and vision to take this opportunity and also lacks the ability or motivation to understand what the EU wants.
